A RESOLUTION AUTHORIZING A CIVIL PENALTY FOR UNAUTHORIZED MOORING AT OLD MILL PARK, MANSON BAY MARINA, AND MANSON BAY PARK:

WHEREAS: The Chelan County Prosecuting Attorney's Office requires a resolution from the Manson Parks and Recreation District Board of Directors,

WHEREAS: Guests of the Manson Bay Marina who have reserved moorage in the Marina and paying for said moorage at time of reservation should be entitled to their moorage on their arrival at the Manson Bay Marina,

WHEREAS: No overnight moorage is allowed at any of the Districts day use docks or Marina breakwater,

WHEREAS: This resolution shall supersede resolution 01-01.

THEREFORE BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF MANSON PARKS & RECREATION DISTRICT, CHELAN COUNTY, STATE OF WASHINGTON, THAT THE FOLLOWING RULE AND PENALTY NOTICE BE POSTED AT OLD MILL, MANSON BAY MARINA, AND MANSON BAY PARK:

A \$100 civil penalty will be charged for unauthorized moorage without prior arrangements with the Manson Parks & Recreation District Office.


- No moorage on day use docks (Manson Bay docks, Old Mill docks, and Manson Bay Marina breakwater) from 2:30am - 6am.
- No moorage in another guests reserved slip (Manson Bay Marina).

WHEREAS, the Board of Commissioners of Manson Parks & Rec. has met and considered
